The Pittsburgh Area Jitterbug Club is a non-profit organization dedicated to the promotion, preservation and education of both "Swing" (aka "Fast") music and "Swing" (aka "Fast") dancing: to include East Coast and West Coast Swing or Jitterbug, Bop, Carolina Shag, Rock n'Roll, Hop, Hustle, Cha Cha, Line and other forms of fast dance, but not prohibiting slower music and dance as time and circumstance permits.

The Club's objective and purpose shall be to encourage, fast and preserve "Swing" dancing and music and to cultivate and promote good fellowship, social interaction, recreational and educational opportunities and loyalty among its members. This shall be accomplished through dances, social functions, lessons, entertainment and special activities.

The **PITTSBURGH AREA JITTERBUG CLUB (PAJC)** is a nonprofit corporation and operates on a calendar year, January through December.

A one-time initiation fee is included in your first year's dues unless there is a lapse or voluntary termination in membership. Once dropped from the membership roles you must reapply. Dues are paid annually in the month of December and at our two dance renewals normally held in January.

Acceptance of your application and deposit of your fee is not to be construed, surmised, or inferred as acceptance into the **PAJC**. Acceptance into the Club will be official upon approval by the Board of Trustees.

All information contained in this Application shall be the exclusive property of the **PAJC** and maintained in confidence. Any and all information contained in this Application will not and shall not be available to the general membership or any outside parties.

A copy of the Club's By-Laws is available to all members explaining the operations of the Club, and is available at the Club.
